In text citations should use the Harvard style in accordance with the School of Business and Economics guidelines. You do not need to include a reference list.


Answer any TWO essay questions from a choice of 4. The maximum word length 1000 words per question.

ALL QUESTIONS CARRY EQUAL MARKS.

1. There has been a lot of popular news around Data, Al and Ethics. Your boss plans to create a new service that mines social media data for emotions to gain quality insights about motor vehicles. Through using these data insights, the boss will report to large car manufacturers about how to improve their brand perception and vehicles by adding or removing components of the car (e.g. cup holders, new 6 wheel vehicles) and the big issues customers are concerned about. Your boss wants a report on the potential risks of providing this service drawing on your experience of using Python to mine Reddit Data, and your thoughts on the various ethical concerns and perceptions of using peoples' data. Use the 5Vs to provide a framework for your answer

2. Information governance is an important aspect of any business. Your boss wants to learn about information governance and would like you to write a short report on just three of the 9 key dimensions associated with an information governance framework. In addition, provide examples for each of the three dimensions on how they will impact the business and possible techniques that could be employee to improve information governance.

3. You have decided to set-up a new company that will offer pay-as-you go electrical cars. There are many business risks associated with this new start-up, for example, customers not returning the vehicle, the vehicle being damaged, the customer not paying. Detail how Descriptive, Predictive, Prescriptive and Cognitive Analytics will aid and/or hinder your business. Identify and describe the data sets that could be used. Where possible provide specific examples to help your boss understand your proposed approach.

- 4. You have just joined a new company. When joining the new company, you discover that trying to locate digital sources of information is difficult. You've decided to write a short report about metadata for your manager detailing:
 - Why metadata is important to the overall information landscape;
 - Outlining potential advantages and disadvantages of using metadata detailing the key types of metadata;
 - Describe the differing sources / types of metadata (auto and manual);
 - How metadata could be used within the organisation and how it might increase/decrease costs.
