




Policy

The Centre for Biological Engineering (CBE) shall establish and maintain procedures to ensure that non-conforming or adverse events, including complaints, that could cause or threaten the health and safety of CBE personnel, or cause or threaten harm to the environment or impact quality of the research product and/or loss or damage to material, are identified, reported and investigated promptly.

The CBE shall ensure that any corrective and preventive actions taken to eliminate the causes of the actual or potential occurrence of the adverse event are appropriate to the magnitude of the problem and commensurate with the risks and impact encountered. Records of the nature of non-conformities, adverse events or complaints and any subsequent actions taken shall be maintained.


