Policy

- Reviewing corrective action taken.

The CBE shall determine actions to eliminate the causes of potential non-conformities or adverse events in order to prevent their occurrence. Preventive actions shall be appropriate to the magnitude of the effects of the potential problems and commensurate with the risks involved.

The CBE has established and shall maintain procedures that define requirements for:

- Determining potential non-conformities/adverse events and their causes.
- Evaluating the need for action to prevent occurrence of non-conformities/adverse events,
- Determining and implementing action needed,
- Recording the results of action taken, and
- Reviewing preventive action taken.
