

The Centre for Biological Engineering (CBE) management shall review the organisation's Quality Management System (QMS) at planned intervals to ensure its continuing suitability, adequacy and effectiveness. This review shall include assessing opportunities for improvement and the need for changes to the QMS, including the Quality Policy and Quality Manual.

The input to management review shall include information on the following:

- Results of internal and/or external inspection audits,
- Registered complaints,
- Status of preventive and corrective actions,
- Follow-up actions from previous management reviews,
- Documentation that has reached its review date,
- Change in circumstances, scope, scale or risk, such as research, process, capacity, or other operational or organizational changes,
- Changes in relevant legislation, regulatory standards or guidance,
- Recommendations for improvement in effectiveness and efficiency

The recorded output from the management review shall include any decisions and actions related to the following:

- Improvement of the effectiveness of the QMS and its processes,
- Resource needs.




